Continue to upskill staff and develop confidence with delivering PE. This should ensure high activity and quality in PE lessons from all staff.

Continue to work with play leaders and MTS staff to develop an active playground.

Create more activity opportunities for targeted groups throughout the school day.

Develop further competitions and festival opportunities

SL to hold training and work with specific targeted members of staff through team teaching.

MTS staff to work with SL on developing an active playground. SL to also work with students to create play leader initiative that will support activity across the school.

SL time to continue to develop schemes of work and hold staff meetings regarding developing a holistic curriculum

Utilise sports apprentices to ensure high quality teaching and more activity opportunities.

Expected impact and sustainability will be achieved

What impact/intended impact/sustainability are you expecting?	How will you know? What evidence do you have or expect to have?
<p>Raising the profile of PESSPA should begin to make these areas feel important to children who in turn will want more engagement and participation.</p> <p>By increasing time the SL can spend working with teachers and TA we are hoping their confidence and competence at delivering PE continues to improve. This will allow their expertise to be passed on to other members of staff.</p> <p>Sports apprentice implemented to deliver more activity for children and support teacher development further</p> <p>Training students to be play leaders along with MTS staff should develop an active playground. This will also create more opportunities for clubs and activities for children to engage with.</p> <p>Investment in equipment will also allow for more activity in lessons as well as a wider opportunity for engagement in different sports and activity.</p> <p>Offering children a broader range of sports activities and events will allow children greater experiences and to get involved in different sports. This would hopefully increase confidence and activity.</p>	<p>We will survey children about their thoughts and feelings around PESSPA after experiencing the different initiatives put in place.</p> <p>We will talk to staff through staff surveys and questionnaires. We will identify the impact the CPD offered has had and how it can be improved.</p> <p>We will look at data regarding participation and competence to see the impact the use of our sport apprentice and club offerings have. This will then inform any offers and initiatives for the following year.</p> <p>Focus groups with MTS staff and Play leaders will inform us of the development of the active playground alongside observations of the children.</p> <p>We will observe lessons and clubs to see if equipment has enabled a broader range of activities as well as greater engagement.</p>

Expected impact and sustainability will be achieved

What impact/sustainability have you seen?	What evidence do you have?
<p>Members of staff becoming more confident in delivering our curriculum through work with SL and training around the use of our online schemes</p> <p>Sports apprenticeships have also enabled delivery of more clubs covering a wide range of sports and PE initiatives. They have allowed us to target certain groups and are now embedded in weekly timetables to continue next year</p> <p>MTS and PLayer leader staff have become more confident delivering different games and setting up environments that promote physical activity.</p> <p>We have continued to ensure a large number of competitive opportunities for our students through creating our own events as well as the Barnet sports partnerships.</p>	<p>Staff surveys and questionnaires support this increased confidence although it is clear we can continue to develop this. Further support in this area is still a key target.</p> <p>Observations from PE lead also suggests improvement in delivery from our staff delivering PE much of this is due to better understanding of using our planning and organising lessons. In turn this is creating more competent and confident children</p> <p>MTS interviews indicate confidence with organising the active play with interest to expand this further. This can also be seen by observing the children at lunchtimes.</p> <p>Club registers and sports data clearly indicates an increase uptake of extra curricular activity in KS2 as well as attendance at festivals and events.</p> <p>Feedback from student focus groups suggest they are connecting with our curriculum and are highly engaged in a range of sports. They have enjoyed trying new PE topics and sports but would like to expand this even further with more ownership.</p>
